### BACKGROUND (Includes description, background, and justification)

The Hogansville Planning & Zoning Commission has two members – Gayle Devereaux and Carol Smith – whose twoyear terms expired January 31, 2019. A third commission member – Carolena Lynch – is leaving the P&Z commission. On November 19, 2018, the City advertised the three openings on its website and via utility mailers. Ms. Devereaux and Ms. Smith would like to be appointed for new terms; and the City received applications from Mary Ann Neureiter and Ellen Shellabarger who wish to serve on this commission.

On February 21, 2019, the Hogansville Planning & Zoning Commission, in regular session, recommended that City Council reappoint Gayle Devereaux and Carol Smith for another two years, and appoint Ellen Shellabarger to replace former member Carolena Lynch.
