Call to Order: Mayor Stankiewicz called the regular meeting to order at 7:00 pm. NEW BUSINESS

1. Watershed Monitoring

Motion: Council Member Neese moved that letter proposal from CCR Environmental to perform 2020 chemical water quality monitoring within the Hogansville watershed be approved. Proposed cost for this watershed monitoring not to exceed \$10,370. The motion was seconded by Council Member Ayers.

Discussion: Interim City Manager Lisa Kelly explained that the proposed water quality monitoring is required by the Georgia Environmental Protection Division and City's Watershed Protection Plan as part of the City's operation and maintenance responsibilities for the new wastewater treatment plant.

2. Annual Watershed Monitoring Reporting Agreement

Motion: Council Member Neese moved that letter proposal from Turnipseed Engineers to prepare annual watershed monitoring reports, based on CCR Environmental test data be approved. Cost of this report not to exceed \$4,500 per year. The motion was seconded by Council Member Price.

Discussion: Interim City Manager Lisa Kelly explained that the proposed reports are required in

connection with the watershed testing.
