

The city of Hogansville is responsible for any repairs or replacement if damage is done to the church property as a result of the city's use of the First Baptist Church Hogansville's parking lot.

The terms and conditions associated with using the First Baptist Church of Hogansville's Parking lot are as follows

No overnight parking allowed. Vehicles will be towed at the owner's expense A calendar of court dates must be submitted to the First Baptist Church Office every six months or more frequently

Events scheduled at First Baptist Church take precedence over the use by the City of Hogansville

At the conclusion of Traffic Court, the parking lot must be inspected for trash and debris left by individuals that used the First Baptist Church of Hogansville's Parking lot during the City of Hogansville's Traffic Court.

FOUR (4) parking spaces nearest the church's entrance on the Johnson St. side of the church building must be blocked off for use by the FIRST BAPTIST CHURCH members.

If violations of the above terms and conditions, the city of Hogansville will no longer be allowed to use the First Baptist Church Hogansville parking lot for Traffic Court.

I agree to hold First Baptist Church Hogansville harmless from any and all claims, loss or damage to my personal property, liabilities and costs, including attorney's fees, as a result of using the First Baptist Church Hogansville's parking lot during City of Hogansville's traffic court.
